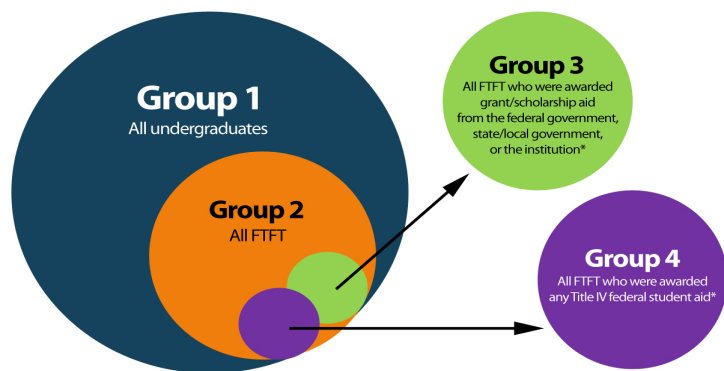
Overview

- COA Revisions
